## NEW GENDER COALITION FORMS

The historic inaugural meeting of the **Garden State Gender Coalition** took place on January 30, 1993. Support groups from three states, New York, New Jersey and Pennsylvania, were represented. Thus, in actuality, this was a tri-state regional conclave. The Coalition was hosted by **Renaissance** affiliate M.O.T.G. at their meeting place in Monmouth County, NJ (just a stone's throw from the recently battered Jersey beaches). A total of seven gender support groups were represented by the following participants:

**Sigma Nu Rho - Tri Ess**, Donna Marie

**Renaissance, Greater Philadelphia Chapter**, Maryann Kirkland and Michelle Lynn

**Gender Identity Anonymous**, Kate M. and Jennifer

**Renaissance, South Jersey Chapter**, Terry M.

**Monmouth Ocean Trans Gender**, Elaine M., Roz L. and Terry M.

In addition to the above representatives, the meeting was also enriched by the presence and contribution of long-time activist Jane Peabody. Ms. Peabody was very active in the old **Phi Chapter**, which, as some may know, was one of the predecessors of Renaissance.

The overall theme of the meeting was one of celebration: of each other, and of our growing gender community. In the past, there have been rivalries and frictions between the groups and the segments of the community that they represent. These differences, however, were set aside for a few hours as a spirit of cooperation and communication permeated the meeting.

Many issues were discussed. Each representative presented an outline of the focus, structure, activities, and future plans of her particular group. Some of the highlights were:

\* **Sigma Nu Rho's Donna Marie** discussed her plans to do greater outreach via the media. She also announced that Tri Ess has pulled its annual "Holiday en Femme" event out of Denver, Colorado this year in support of the boycott being waged for gay and lesbian civil rights.

\* **Gender Identity Anonymous**, a twelve step emotional support group, has changed its format and meeting place. This group, formerly Survivors of Transsexuality Anonymous, is now independent of S.T.A. of NY.

\* Maryann Kirkland and Michelle Lynn outlined many of the exciting social activities planned by the **Greater Philadelphia Chapter of Renaissance** for the upcoming I.F.G.E. Convention in Philadelphia. They also provided numerous suggestions for the Coalition, e.g., using "Renaissance News" and the I.F.G.E. national office as Coalition resources.

\* **M.O.T.G.'s Elaine M., Roz L. and Terry M.** discussed some of their recent programs. Most notable were the successful shopping spree at the Bra and Girdle Factory and the excellent presentation by NJ American Civil Liberties Union Director Ed Martone. As a result, M.O.T.G. as a group has joined the A.C.L.U.

One of the suggestions brought forth was that groups make an effort to visit one another's meetings. This was greeted with universal agreement. It is of special importance to note, therefore, that even the "closed" groups would welcome visits from all types of sisters.

Some of the other major points of agreement discussed:

- to enhance inter-group networking and referral of new member contacts by exchanging updated and accurate group information with one another

- to enhance outreach both to the greater gender community and the general public

- to provide information about our community to professional psychological and counselling services

- to begin a state-wide drive to contribute books and other pertinent material about transgender issues to county libraries

Finally it was agreed that our most important effort is to reach out to our sisters who still suffer alone in the closet.

Several other proposals were also set forth. Some of these ideas are already in action within the individual groups and will be on future Coalition agendas. They include:

- establishment of a regional speakers bureau

- alliances with the gay and lesbian community and participation in mutually beneficial projects with them.

## ROGER'S NOTEBOOK (#77)

Recently I have had the opportunity to appear on television shows as "the expert du jour" as my wife describes my role. My rationale for taking time out of my busy schedule for these shows is simply that I hope to be able to provide some professional objectivity and balance to what can otherwise be a circus for ratings. There is no pay for such appearances and I do not get clients as a result of my appearance.

The producers who actually assemble these shows do a tremendous job in finding and persuading people in a particular situation to appear on the show. Sometimes they have to resort to disguises or hiding people's identities through a variety of camera techniques. In the end of their job is to get enough people on the show to make it good entertainment.

When you appear on such a show you usually sign away your legal rights. This is called a "release" and it basically says you can't sue the show or the network if your appearance causes problems for you. Also, you need to realize that you may not know the other people who will be on the same show with you. Lastly, it is crucial to remember that no one associated with the show is formally

trained in assessing or dealing with the psychological situations brought up by an appearance on the show. Basically, the purpose of the show is "entertainment" by showing (exposing) intimate aspects of otherwise normal people's lives.

With this rather long preamble, let me describe a recent experience. This show was exploring the impact of transsexualism on people's lives. One aspect of such an impact was represented by a family in which the father was post-op male to female transsexual. Prior to the show, I had an opportunity to talk with the ex-wife. It was obvious to me that she was quite upset by the prospect of appearing with her ex-husband on this show. She had been assured by her therapist that it "would be good for her." This couple had been married for about 20 years and the ex-husband's final transition was very recent having taken place less than six months ago.

The show came on and the family appeared. Because of the number of people on the stage no one had much time to tell their story. In particular, this couple was not able to say very much about their situation. Things remained calm until the show was over. Then the woman

became highly distraught. She began to scream at her ex-husband that she hated him for what he had done to her, then she broke down and cried uncontrollably. Clearly, appearing on this show created emotional strains she was unable to manage.

Is there "blame" in this situation? Probably none that have legal consequences. However, there seems to be a lesson here. Television talk shows are entertainment, not therapy. They also provide a very limited forum in which to do any real education. People who agree to appear on such shows need to realize that they are at the mercy of the producer. Further, once you have appeared, the "genie is out of the bottle." Your privacy has been invaded and your emotions laid bare.

There is an acronym I use in workshops I do to help people analyze decisions -- MARC. It stands for Mutual, Appropriate, Responsible and Consequences. Probably the most important here is Consequences. When appearing on public television, be sure you analyze the possible outcomes. If some seem to be problematic, then perhaps it is better not to participate.

The various discussions offer some clear insights into various aspects of each topic. The book as a whole tends to be technically written, though still very readable. Included are some excellent photographs of the actual phases of reassignment surgery in a male-to-female transsexual. For those of us who want to know more about the basic issues and problems involved in sex reassignment, both male-to-female and female-to-male, this is an excellent introduction.

Gays and Lesbians know their Out In Numbers strategy will eventually work judging from pervious polls that have shown an increase in tolerance and acceptance by those who do "personally know someone who is..."

Our silence can truly equal death. The next gay bashing statistic may be you, sister! And the Republican conservatives and the religious right are already organizing their counter-attack to block President Clinton's opening of the military for gays and lesbians. We must seize this moment, or retreat to suffer countless more decades of fear in our closets. Come to Washington this April 25. The drums along the Potomac are beckoning you.

## Closet or Change: A Choice and A Chance

Washington, DC: The sounds of the drums are beginning to boom once again along the Potomac. Sounds I've not heard since the sixties, when I was a child. From the summer fury and fall campaign, the winter seeds have been sown. A dream is beginning to take root as a fragile flower blossoming in the chilly spring air. The natives are restless as the winds of change sweep in from the north, south and west. The people have spoken: change is what they want and change is what they'll get. Or will they?

Any student of politics cannot help but notice the striking parallels between 1961 and 1993. A new, young president comes to office after a decade of stagnation. Then the issue was race, now it is sexual orientation, but at heart it's still the same cause: basic civil rights. The right to freely associate. The right to housing. The right to be hired and promoted without job discrimination. The right to serve in the armed forces of your country. And yes, if you remember the anti-miscegenation laws, the right to love and marry whom you choose.

But as Aristotle said in *Politics*, "the goal of political studies is not knowledge, but action." Unlike many African-Americans thirty years ago, American Gays and Lesbians have always had the right to vote. Now they have helped to elect a president who actually listens to them. And if those of us who care don't rush to his side to fight the conservative backlash, Bill Clinton's election will be for naught.

It is commonly accepted that the largest subgroup of transgendered persons in our country are the heterosexual cross-dressers, so most of this is for you. If you are like most of your totally straight counterparts, many of you feel ambivalent about (if not distinctly apart from) the larger Gay and Lesbian community that harbors us. Some of you may feel a visceral disgust of homosexuality in general and some of you may even be homophobic. Thus, it may be very diffi-

cult for you to understand how much you really do have in common with homosexuals. And the prevailing politics of our recent past have not done much to raise anyone's consciousness.

Unless you've been asleep, you might have noticed how effectively the Republicans and conservatives have controlled this country over the past twelve years. They did it by carving up the electorate into small subgroups they could manage by single, wedge-issue politics, like abortion, gun control or Willie Horton. Or, even better, they set group against group by emphasizing the differences between people instead of our commonalities. They became the masters of the politics of division, using pro-choice advocates, single mothers, African-Americans, Gays, Lesbians, and others as their whipping boys.

In our own (male to female) transgendered community the drags are very different from the crossdressers who are very different from the transsexuals. Yet, we all wear dresses, and we all suffer for it. So we band together for the security of our little insular groups. And over time, in order to attract members and survive, more and more transgendered groups have learned to practice the politics of inclusion, opening up their doors to members of different sexual orientations and genetic origin. Solidarity forever, everyone?

But despite our trend toward openness, it is still quite easy for us to forget our common bond with Gays and Lesbians. We, transgendered and homosexuals, are all born different to a society that neither understands nor accepts us. When discovered, we face the very same discrimination directed at Gays and Lesbians and we also fall victim to acts of violence and harassment. Indeed, according to one recent estimate, half of the gay-bashing incidents committed in New York City have been against transgendered persons, because we are much more easily "read." The medical, legal and insurance problems faced by transsexuals are enormous, due largely to a lack of the public's understanding of us. Simi-

larly, when the HIV epidemic first broke out in the gay community, the public was largely unaware of the suffering, not only from the disease but also its ramifications.

Our invisibility, the essence of our existence, is a blessing and a curse. The safety it provides us also prevents the public from understanding us. Almost all transgendered persons live closeted lives, as did almost all Gays and Lesbians just 24 years ago. In those days they also felt it too dangerous "to be out" because of the scorn and ridicule they would face. That is, until a group of Latino drag queens rioted against the police harassment they faced at a small gay bar in New York City. Until Stonewall. Today many of them can walk openly in the sun, cautious but free to express who they are and who they love. Working with and learning from them, we could get there too someday. A future without fear. Imagine that...

But, because fear has held us so long in its iron grip, our vision has dimmed as we view our lives in the perpetual twilight of our closets. We are, each and every one of us, witnesses to the endemic fear, apathy and self-loathing within us. Sisters, the Gays and Lesbians have been there. In talking and sharing with them, I have found almost all of them happy to have us stand with them. Many are stunned to discover the common bonds we share with them. But up to this point, apart from a very few courageous individuals, the only politically active transgendered subgroup with whom they have had experience has been the drag queens, who are mostly homosexual themselves and thus more connected to the larger Gay and Lesbian community and its issues. Many in the Gay and Lesbian community see the drags as the sole representatives of the rest of our tiny closeted transgendered community. Must the silence of the TV/TS lambs linger forever?

We have a choice, and a chance, for change. This year we can make a difference by coming to Washington, DC, for the 1993 March On Washington for Les-

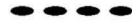

All of a sudden I heard the leaves crackle as the intruder approached. Suddenly, there he was, revealed to be a police officer by the illumination of his flashlight. Before he could utter a word I began to explain the situation to him. I told him not to be alarmed. I belonged to an organization for crossdressers and I had merely stopped there to change my attire. Curious, he shined his light into my cab and was taken aback by what he saw. The voice of a man but the likeness of a woman! He seemed dumbfounded. He didn't know what to say. Then he apologized for startling me and explained that teens were known to frequent the park to do drugs. I assured the officer that was certainly not the case and he told me to, "take all the time I need" and went to his cruiser and drove away.

I learned that night that if you maintain your composure and treat the officer with respect chances are the police are only after the bad guys. Thank the Lord for those guys and gals of the Warminster Township Police Force.

There you have it. I only hope that this story will enlighten our sisters and ease some of their pent up fears of being discovered.

I finally emerge into reality to find myself a middle-aged, first-time father, financially responsible for other people. No matter how sexy the outfit, we can no longer justify the expense both of us can use it. I find a closet full of clothes that do not suit my wife and I don't really

enjoy wearing. I think I look good with a beard and the baby likes it. She's already got a pretty mommy who looks great in a dress and make-up. Will I confuse or amuse her?

I work quietly to make real the dream of a time when gender and sexual identity and orientation will be no more important than political party affiliation. When there will be peace and justice for everyone. But until that day arrives, how do we raise her? How and when do we tell her about her daddy's other dreams? What attitudes should we share with her?

Probably half the members of Renaissance have children. No matter how

different we are, most of us want to do the best we can for our children while maintaining our own selves.
