### Editorial

1986 was a year of change in the transsexual support community. The first casualty was GGA, the Gateway Gender Alliance. Georgia Saunders announced her retirement and the organization was taken over by Sharon Renee Hart of the Windy City Chapter in Chicago. Georgia held the rights to the name GGA and Sharon had to change it to National Gender Alliance (NGA).

Another casualty was TVIC Albany. This group had been run for many years by Wilma Thorsden, who also decided that the time for retirement had come. The group was taken over by a member in the Boston area, but soon folded.

A Canadian casualty occurred in Toronto at the end of the year. FACT Toronto had been plagued by dissention for almost a year and a dissatisfied group took over control and withdrew from FACT, renaming the organization Transition Toronto. This group has no connection with FACT at present.

Finally, the rumour got around that FACT itself had folded. This is not true. Susan Huxford, as Executive Director of FACT, had for years been urging that it was time that members of the organization took responsibility for running their own affairs. The Constitution had been suspended at the beginning of 1983 and Susan had run the Foundation single-handed for over three years, in spite of the fact that the terms of the suspension of the Constitution set out means by which it could be reinstated. These terms required twelve members to request the Executive Director to call an election of officers, provided that the twelve would themselves present a full slate of candidates. This was never done and Susan was left with the impression that she would have to

continue to run FACT until she dropped dead.

In February 1986 a birthday party was held by the then FACT Toronto in celebration of Susan's sixty-fifth birthday. The implications of this event apparently escaped everyone's notice. Susan intended to retire and devote her time to GenderServe and other professional activities. She therefore approached a number of responsible members with a view to reinstating the Constitution. Things moved very slowly until September and a meeting was eventually held in Toronto on Saturday, September 13, at which Susan handed in her resignation as Executive Director of FACT with effect from September 15. This proved to be just as well. Susan was overloaded with commitments and fell victim to a virus, the after effects of which affected her breathing for months. This has resulted in the virtual suspension of all activities in the GenderServe office since the beginning of last September. Since Easter it has been possible to start work again on a limited basis.

The reorganization committee of FACT is now in the last stages of its work. The Constitution has been revised and a provisional Board of Directors has taken office. Steps are being taken by the new officers to obtain incorporation in Ontario as the Foundation for the Advancement of Canadian Transsexuals. Members of FACT are being notified by the new executive of these arrangements and efforts are being made to obtain a mailing address in Toronto. Mail addressed to FACT at P.O. Box 291, Hamilton, Ontario, L8N 3C8, will experience some delay, but will be forwarded to the new Executive Secretary. Susan Huxford will continue to serve FACT as Treasurer.

**Gender Review**
