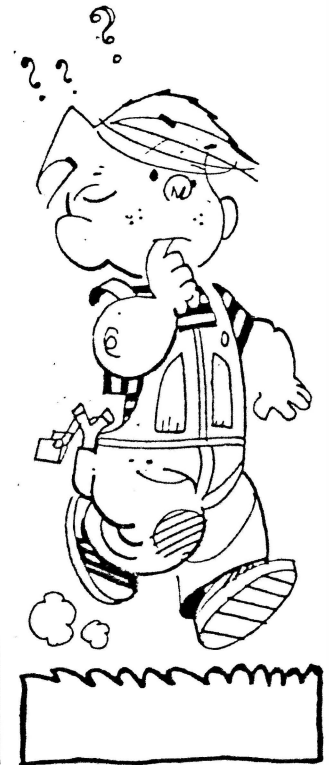
CHI'S JUNE MEETING . . . . .

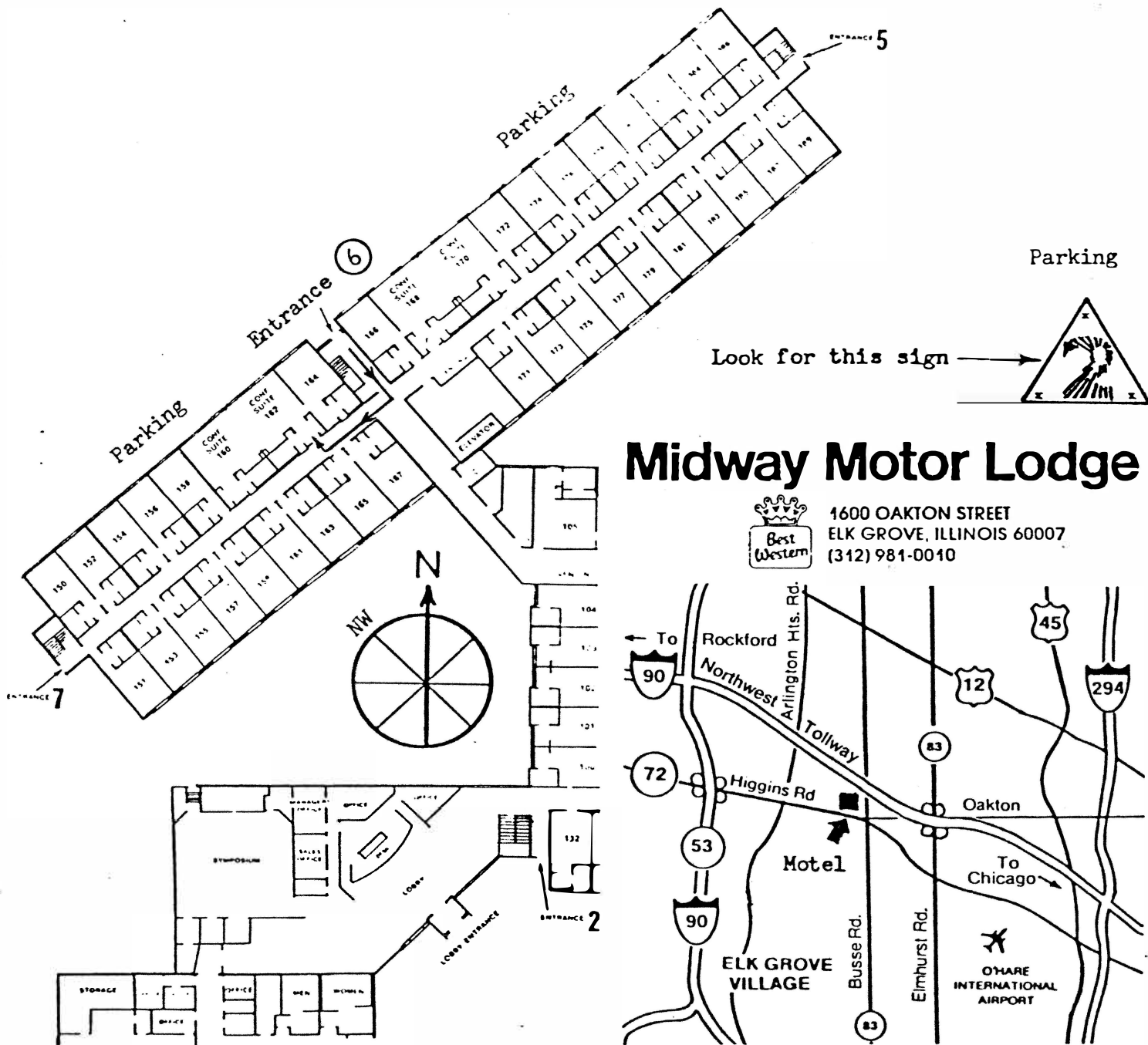
