Every member of that family is our sister, different, yet deserving our love and our understanding.

Ariadne expresses pessimism, Paula hopeful pessimism, Patricia optimism, and Carole and I as though the holy grail were around the corner. So whatever our private attitudes, let's get together and do what we have to do to get what needs to be done, done.

AGENDA: As you might expect, I have a few thoughts on how I think the meeting should go.

brier discussion and analysis of the social and the service needs of crossdressers. Then we should 2.) establish long range goals, then 3.) short range goals, and 4.) what we are going to do to achieve these short range goals.

Since the analysis of needs has been discussed before, and the long range goals are a direction and not of immediate importance, let us concentrate the bulk of our effort on the short range goals and how we are going to achieve them. To establish what we are doing and why we are doing it; figure out where and how it is going to be done and who's going to do it.

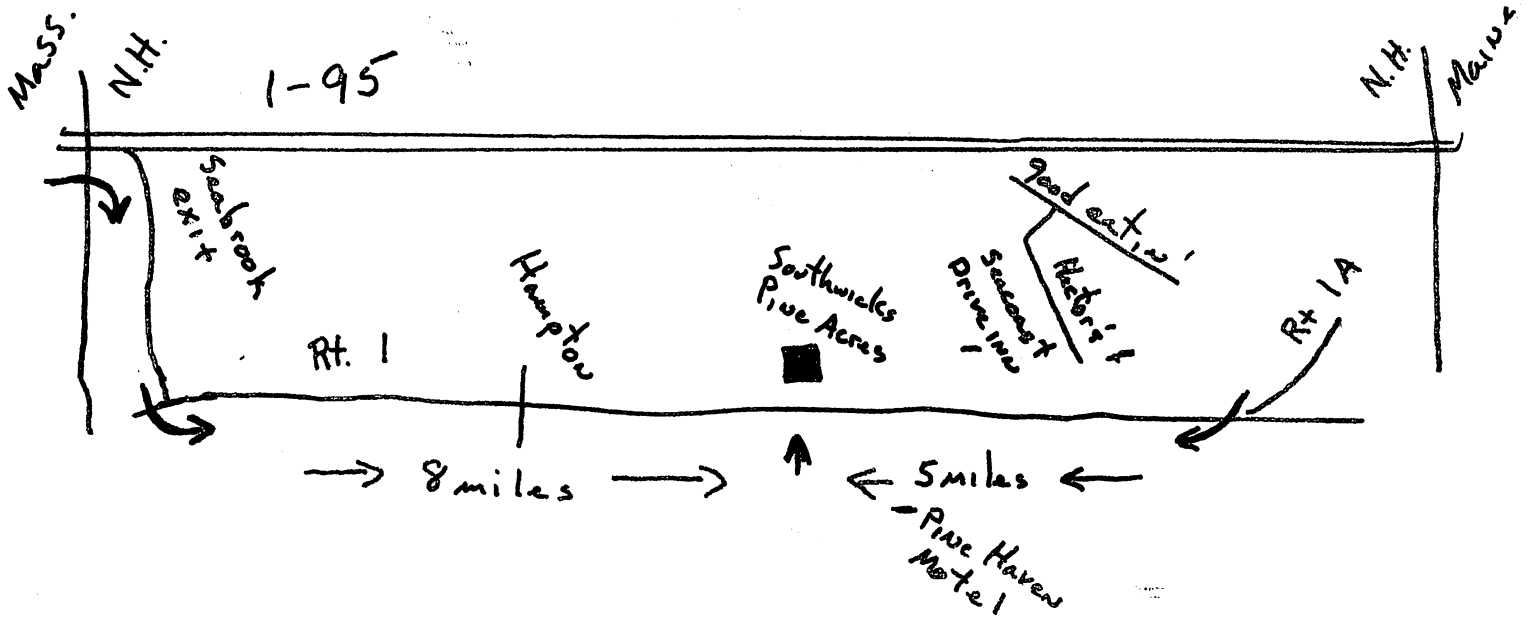
Let's do it. See you 8pm Sunday, 11/26 at my place.
