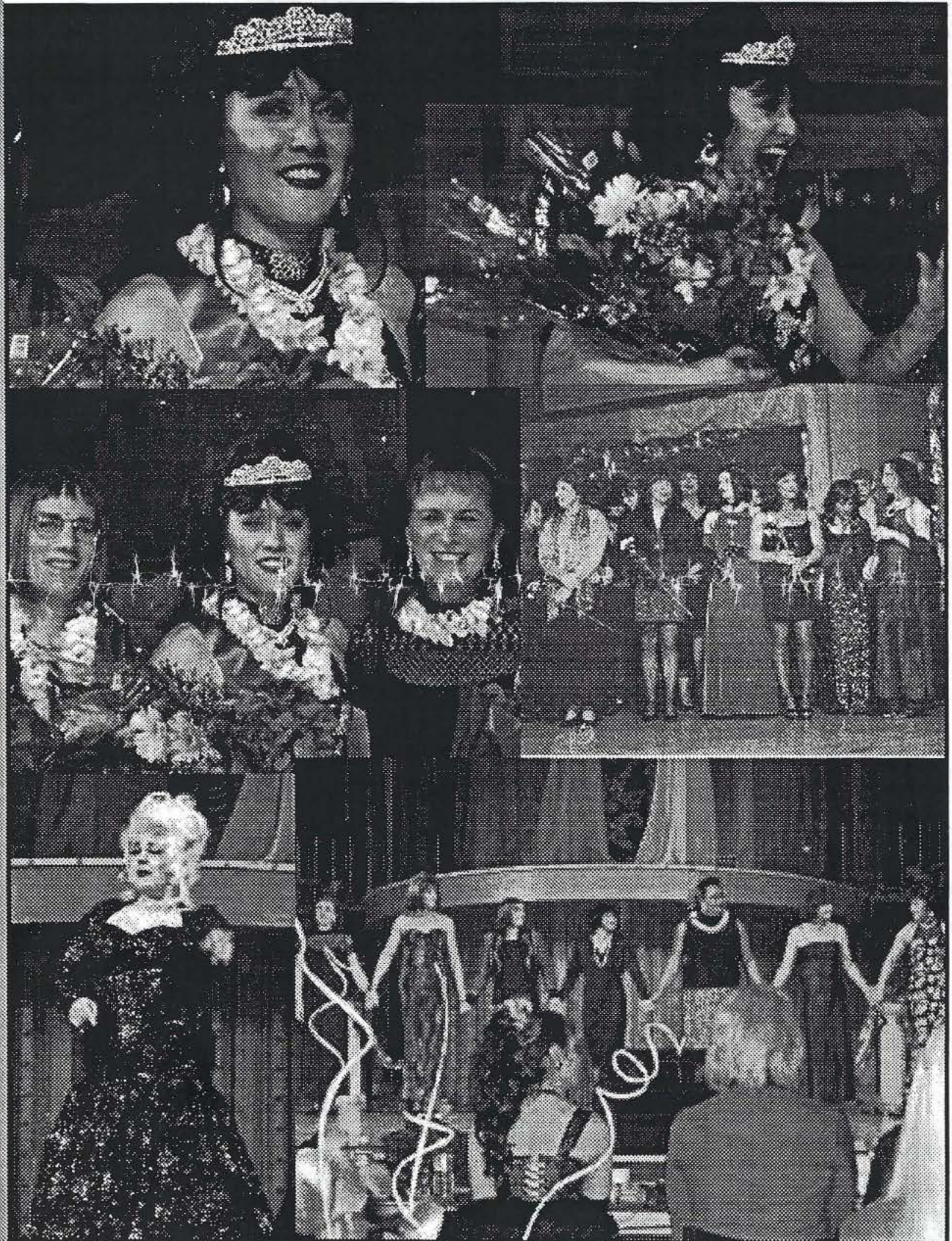

# Our Readers Respond

## Seminar Review

### PLASTIC SURGERY WITH DR. BRINK

Dear Editor:

I attended the seminar "Face-Time with Dr. Brink" on January 12, and was delighted to learn about Dr. Brink's sensible and realistic approach to plastic surgery. It is a type of approach to consider not only for plastic surgery, but also for gender transition in general.

Dr. Brink gave us a lot of food for thought: how facial features relate to a person's frame size, the "gender overlap" in facial features, and that even supermodels' features rarely conform to all perceived standards of femininity. Dr. Brink does not "sell" a standard full-face surgery package that few of us can afford. Instead, he utilizes computer imaging to tailor an individual surgical plan to each patient's needs and expectations. He also indicated that the cost of his procedures is significantly lower than some of the amounts we are used to hearing in the community. If I were shopping for a plastic surgeon again, Dr. Brink would certainly be on my "must see" list.

When I had my facial surgery done 18 Months ago, I asked Dr. Meltzer for an approach similar to what Dr. Brink favors. I wanted some enhancements, but not a new face. I'm glad I did it that way. The features I had been self-conscious about have been smoothed out, but it is still "me" I see in the mirror. To put this in perspective, the surgery did allow me to pass as a female without even thinking about it. But it did not change the love I felt for myself (or the lack thereof). Learning to love myself was a whole different process. It evolved as I learned to accept and appreciate my femininity, and gradually allowed it into my life.

I have never been known as someone to do radical things quickly. When my gender therapist pressured me to set target dates, I insisted on doing things at my own pace—each new step when I felt comfortable with the previous one. It took seven years to be where I am now. I started with testosterone blockers to stop from masculinizing further, and focused on electrolysis (a never-ending process, it seems). I developed feminine behavior, voice, looks, etc long before I started living full-time. While this made some people speculate, if I had 'become' gay, it gave me time to prepare for the worst-case scenario (losing my job) without risking to lose everything I have.

As it became increasingly difficult to pass as a male, I knew I was ready for the big step. When I announced it, many people were not so surprised. They had observed the changes over a longer period of time, and realized that I appeared happier. A happy person—someone who smiles, listens and interacts—is usually not considered a threat, and has a much better chance of being accepted.

The issues I experience today are rather typical for genetic females. One of them is not being taken seriously by males, especially when it comes to technical issues. I have learned to lean back, listen, and when the BS becomes too much, I rock the boat by asking the right questions (providing I know the answers). I never knew how much power could be in a question...

Am I perfectly feminine in all aspects? No, I wouldn't say that. And it was never my goal. I am myself—a mixture of male and female. I changed what needed to be changed and left the rest alone. It has worked for me. And I am glad there are providers who support this type of approach. They deserve more business from our community.

### ABOUT "FIRST MONDAY"

If you are not aware, a new show began on network television last night with regular broadcasting to be on Fridays. It is called "First Monday" and is an hour long drama about the inside dealings of the US Supreme Court. In its opening show, the first case before the Court dealt with a cross-dresser immigrant Petitioner seeking political asylum. I've been asked a dozen times already what my first impressions of this show were, and they are as follows.

I saw it too and was very surprised that we got such good coverage on the first show. Sure it had problems, but the words cross-dresser, transgender, transsexual and transvestite were all used and distinctions were drawn. I wonder how much of it had to do with Alyson and me coming so very close to getting the Littleton case heard last year by the US Supremes (see the Littleton Petitions for Writ of Certiorari at [www.transgenderlegal.com](http://www.transgenderlegal.com)).

In the story line, the cross-dresser Petitioner was pretty well trashed by the actors representing Justices of the Court. While I did not enjoy hearing that language, it was very sobering because it certainly is the way that our enemies talk about us, it is most likely the way we will be treated when our cases come before this Court, and it serves as a warning to us that we need to be better prepared than was the lawyer in the show.

The later, salsa dance scene was instructive to the viewers also. If you did not see it, a male clerk who was very sexist and very insensitive to the plight of the cross-dresser Petitioner, needless to say was heterosexually turned on to the lawyer. After she deliberately got him completely, sexually stimulated on the dance floor, she informed him that she was a three-year, post-operative transsexual. He crashed, and I was glad.

My guess is that the first TG lawyer to try a case at that level will either be Alyson Meiselman, Jen Levy, Beth Plottner, Shannon Minter or Spencer Bergstedt, or we will certainly have one or more of them on the team. My guess is that from the TG lawyers I know, and the supportive teamwork that was displayed to Alyson and me when we worked on the Littleton case, our community will have a good legal team.

But, NOT IF WE DO NOT SUPPORT THEM. The community support that Alyson and I received on the Littleton case was approximately \$3 per hour. It will take a better base than that next time around. (I suggest that you support the TGFund at [www.tgfund.com](http://www.tgfund.com).)

## Movie Review

### PROSTITUTE SEEKS SEX CHANGE IN MOVING 'PRINCESA'

"Princesa" is a sympathetic look at what it's like to be a Brazilian transsexual prostitute working in Milan. The picture tells the story of Fernanda, a 19-year-old who lives in a zone in between male and female. The equipment is male; the presentation is female. Fernanda (Ingrid de Souza) has augmented breasts and long hair and looks a little like former MTV video jockey "Downtown" Julie Brown. All Fernanda wants is a mundane middle-class existence, a husband, a house, and a conventional domestic life. But in order to achieve that, Fernanda must raise money for a sex change, and to raise money, she immerses herself in the squalid existence of a prostitute. The first 15 minutes, which depict two lewd sex acts, can make an audience wonder if "Princesa" is going to be nothing more than a depressing and exploitive wallow.

It's not. Director Henrique Goldman, who also co-wrote the screenplay, does not aim to shock, titillate or gross out his audience. Rather, Goldman wants to create a faithful character study. Inspired to make the film by the autobiography of a transsexual prostitute, Goldman depicts Fernanda's half-world with humanity and specificity.

Apparently, there are a lot of Brazilian transsexuals and a lot of willing clients in Italy. Who knew? Fernanda makes her way to Milan and comes under the wing of Karin, an Italian madam who might just as well be called mister. Most of the movie concerns Fernanda's relationship with Gianni (Cesare Bocci), who picks her up one night thinking she's a woman, and the next thing he knows, he's got his hands full.

Goldman has enough on his plate explaining Fernanda's inner workings, but Gianni is equally enigmatic. Here is a married man, supposedly straight, who has no interest in men. Yet the next day he's taking Fernanda out to dinner and apologizing for his rude reaction to her surprise gender. And within a month he is telling her that he has lost his "old certainties" and knows he loves her.

"Princesa" works best in its unsentimental and respectful attention to Fernanda's predicament. Is she a woman stuck in a man's body and ready for a sex change? Or is she, in fact, someone who should stay in that in-between zone? The scenes of Fernanda meeting with a counselor to discuss the pros and cons of sex-change surgery are no-nonsense. The viewer comes away feeling the seriousness of this choice.

Goldman uses real-life transsexuals rather than actors, and the casting itself adds enormously to the depth and atmosphere of the film. It's possible that a nontranssexual could have played Fernanda, but it's hard to imagine any actor (or actress) whose look and essence would be more right than that of de Souza, who sometimes looks female and sometimes looks . . . who can say? — and whose face has the gentle and haunted look of a born outsider.

### ACLU Informs Appeals Court PUBLIC SCHOOL RIGHTLY GAVE SEPARATE RESTROOM ACCESS TO ANTI-TRANSGENDER TEACHER

ST. LOUIS — A public school in Minneapolis met its legal obligation by giving alternate restroom options to a teacher who did not want to use the same facilities as a male-to-female transgendered employee, the American Civil Liberties Union said in papers filed in federal appeals court today.

Southwest High School teacher Carla Cruzan complained that allowing transgendered library employee Debra Davis to use the women's bathroom violated Cruzan's religious freedom and created a hostile workplace based on sex. As a result, the school provided Cruzan with ready access to several other bathrooms, including single-person facilities and other women's restrooms.

"Carla Cruzan is the person who thinks there is a problem here, so the school was right to find some other alternative for her," said Tamara Lange, an ACLU Lesbian & Gay Rights Project staff attorney.

Unsatisfied with the school's accommodation for her, Cruzan asked a federal court to block Davis from using the women's restrooms at the school. She lost and is appealing to the U.S. Court of Appeals for the 8th Circuit, in St. Louis. A three-judge panel will hear the case later this year.

In a friend-of-the-court brief filed today, the ACLU said that Cruzan, not the school, was unreasonable when she demanded that the school allow her own personal beliefs to dictate Davis' use of school restrooms. The ACLU, filing on behalf of groups including the Minnesota chapter of the Gay, Lesbian and Straight Education Network, also noted that students, teachers, staff and parents at Southwest High School roundly supported Davis and the school's handling of the situation.

"The Minneapolis Public Schools have shown a willingness to learn about and support the needs and concerns of LGBT students, parents and staff. From students who plastered the walls with signs supporting Debra to the Out4Good office in the Minneapolis district itself - this community is a model for every school in the country," said J.J. Kahle, Co-Chair of GLSEN-Minnesota. "Debra was supported so she could continue doing her good work in the library. While it's too bad that Carla Cruzan is intolerant, her concerns were addressed by finding other restrooms she can use."

Minnesota is one of just two states that explicitly prohibits discrimination based on gender identity - but that civil rights law is not at issue because this case is about whether Cruzan was discriminated against by the school's accommodation of a transgendered employee. The ACLU Lesbian & Gay Rights Project is currently litigating a New York City case claiming that a landlord violated existing sex discrimination laws by evicting a social services agency because its transgendered clients used restrooms consistent with their gender identities. ## Call For Investigation

### FRIENDS REMEMBER FLORIDA ACTIVIST

[NTAC - Dec. 24, 2001] A Florida transgendered activist murdered recently was laid to rest this week. Terrienne Summers, 51, was found shot to death outside her Jacksonville, Florida home on the evening of Wednesday, December 13, 2001. To date, police have no leads on the perpetrator or the motive.

In a memorial service that packed The Norm, a neighborhood haunt frequented by Terrienne, family and friends from around the state and the nation gathered to remember her life and her work.

"Terrienne unified this community," said Cindy Watson, executive director of the Jacksonville Area Sexual Minority Youth Network (JASMYN). "I've never seen anyone with her energy or her drive. In fact, I'd never even met anyone who was transgendered before ... after meeting Terrienne, I knew all about transgendered."

Ms. Summers, a 22-year Navy veteran, was the driving force behind the local Winn-Dixie protest at their corporate headquarters in Jacksonville. Her organizing the local community against the regional supermarket chain was perhaps the crucial element in making the ongoing suit against Winn-Dixie effective. "She really got JASMYN heavily involved in the Winn-Dixie protest," added Cindy Watson during the memorial.

The suit filed by the American Civil Liberties Union (ACLU) against Winn-Dixie pits the corporate supermarket giant against crossdresser Peter Oiler. Oiler was fired January 5, 2000 after he told a supervisor that he crossdressed occasionally. As a result, the ACLU and TBLG activists from around the nation are organizing another campaign on January 4, 2002, at the company's Jacksonville headquarters.

Ms. Summers worked closely with the local ACLU, giving a thorough education on transgender issues. "A co-worker once told me to be kind to everyone you meet. We all have our personal battles to fight," said Ken Hurley, president of the Jacksonville ACLU. "Terrienne truly had her battles to fight. And Terrienne was unfailingly kind."

"Terrienne was an activist's activist," opined Vanessa Edwards Foster of the National Transgender Advocacy Coalition (NTAC). "She didn't get a lot of national notice. But the true measure of an activist is not how much press you get, it's how effective you are. Terrienne was effective."

"Terrienne truly saved my life," stated Summers' roommate Marie Gabriella. "She showed me I wasn't such a bad person for being a transsexual ... she taught me self-worth."

The most poignant words came from Terrienne's father and siblings, who traveled down for the memorial service. They related how they joked on the telephone about their getting the pronouns wrong, or calling her by her old name. Terrienne was very easy with it all; a fact that endeared her to her family. Joe Heiney, a World War II Navy veteran said "I'm very proud of my son - my daughter. Terrienne, Gary ... she was something special to bring all these people together."

"I flew down here from Wyoming, the state where Matthew Shepard was killed. Please don't judge the whole state for that!" remarked Terrienne's oldest brother, Joel Heiney.

In a more somber tone, Joel remembered "the trials for Matthew Shepard's killers, and the pain on the faces of Shepard's parents. I never thought that a couple years later, I'd be speaking before a roomful of people at [Terrienne's] memorial service; and looking across the room and seeing that same look of pain on my

father's face."

The local community, as well as the state and national transgender community, is concerned now with the motive for the slaying. Initial police reports tagged it as a robbery attempt; however, nothing was taken or disturbed during the incident. Information from the authorities is also sketchy and slow in coming, frustrating many in the local community.

At the memorial service, Jessica Archer of Equality Florida, JASMYN's Ms. Watson, and Ms. Foster from NTAC all called for a thorough investigation of her death.

"If this incident would have happened to anyone else, Terrienne would have called for this to be fully and vigorously investigated," stated NTAC Vice Chair and Media Director, Vanessa Edwards Foster. NTAC, as well as Equality Florida, JASMYN and other activist organizations around the nation, are urging a "full and vigorous investigation into the circumstances surrounding Terrienne's murder."

"She would want justice to be served."

## TG MAN FIGHTS FOR CUSTODY

Testimony continued Wednesday in a Florida custody case that could have dramatic implications for transgendered people.

It raises a variety of questions, including: Does Florida law view a female-to-male transsexual as a man? If a female-to-male transsexual marries a woman, is that marriage legal; and if not, does the transsexual have any child custody rights?

Michael Kantaras was born Margo Kantaras in 1959 but completed sexual reassignment surgery in 1988. A year later Kantaras married Linda Forsythe in Lake Mary, Fla., and adopted her one-month-old son from a previous relationship. At the time of the marriage, Forsythe was aware that Kantaras was born a woman. The couple then decided they wanted a child of their own. Using sperm donated by Michael's brother, Linda gave birth to a daughter in January 1992.

In 1998, Michael Kantaras filed for divorce and sought custody of his two children. Linda Kantaras then filed a suit of her own. She claims Michael is not her husband because he was never legally declared a man. And since the state of Florida does not recognize same-sex marriage, she claims they are not actually married and he is not entitled to custody of their children.

"It's typical of the type of problems transsexuals run into," said Denise LeClair with the International Foundation for Gender Education. "She was fully aware that the partner was transsexual. It didn't bother her then, but then she comes back and uses it as a weapon," she told the Gay.com/PlanetOut.com Network.

Michael Kantaras' attorneys are arguing that despite being born a woman, he is now a man and the father of the children and is entitled to all the rights normally associated with husbands and fathers. They also argue that ending his parental rights would be harmful to his children.

The trial began Tuesday with testimony from Walter Bocking, a clinical psychologist and transgender expert who discussed sexual identity from a physical and emotional standpoint. Wednesday, the court heard testimony from Dr. Ted Huang, the physician who performed the sexual reassignment surgery. Circuit Court Senior Judge Gerard O'Brien has played an active role in questioning witnesses throughout the testimony.

LeClair says it's time the government got out of both "the gender business and the marriage business. As long as the government is defining your sex for you and using it as the basis for who you can marry, we will continue to run into these problems," she says.

### WINN-DIXIE PROTEST DRAWS INCREASED SUPPORT

As the spotlight changed to green, semis rumbled through the intersection; yanking hard on the airhorns as they passed. Interspersed between the cars and pickups, the big rigs of various large and small company signage — a couple with large letters spelling "Jesus Is Lord" under the company name — honked their support to those gathered on the sidewalk.

A long, rangy line of people stood along the length of the block in front of a low-slung, unremarkably modern office building in the crisp sunshine. Holding signs with slogans saying "Winn-Dixie Unfair to Transgenders" and "Winn-Dixie & the Taliban Try to Control the Clothes You Wear," the crowd waved and whooped their appreciation at every thumbs-up and enthusiastic honk from passers-by. On this day, supportive passing motorists overwhelmingly outnumbered the vocally negative ones.

Approximately three dozen hearty souls braved the near-freezing winds on Friday, January 4, 2002, to march in front of Winn-Dixie's corporate headquarters in Jacksonville, Florida. Nearly half of the protesters came from outside of the Jacksonville area. Equality Florida sent two from Tampa, and the National Transgender Advocacy Coalition (NTAC) drummed up another thirteen more from Pennsylvania, North Carolina, Iowa, Texas and Louisiana as well as eight individuals from Georgia.

The campaign against Winn-Dixie was held to refresh awareness in the ongoing civil rights case filed by the American Civil Liberties Union (ACLU) against the Fortune 500 food retailer.

At issue is what the nation's transgender community calls a wrongful firing of Peter Oiler - an employee with over twenty years on the job. Winn-Dixie, however, claims they were justified in terminating him after Oiler told his supervisor he crossdressed occasionally on weekends.

Company executives say that an employee who cross-dresses while away from the workplace on his own free time is bad for the supermarket's "image." Critics challenge that argument, noting that the "image" was never a problem in all the prior years the truck driver worked for the company. Instead, they believe this creates precedent for Corporate America to set standards of how employees will live, dress and act on their own personal time.

### TRANSGENDERED BRITONS TO GET RIGHT TO WED

LONDON — Britain's transgendered may soon get the right to marry. The Blair government is said to be preparing legislation to bring into the Commons in this session.

Word of the decision was leaked a day after Britain's Law Lords decided to hear the case of a transgendered woman whose marriage was annulled when it was learned she had not been born a woman.

Thousands of people in Britain who have changed sex are unable to wed because they cannot have their new gender marked on their birth certificates.

Under the plans, said to be under consideration by Lord Chancellor Lord Irvine, are new birth certificates that state the holder's proper sex.

Only Britain, Ireland, Albania and Andorra fail to give transsexuals full legal rights in Europe. Advocates for the transgendered hailed the change, saying the legislation will end more than 50 years of discrimination.

This year's protest brought together both seasoned national activists and first-time activists, and all spectra of sexual orientations and gender expressions.

"It was very inspiring to me that I could actually be a part of something that made a difference," said Veronica Wilson, president of the local Jacksonville Area Gender Society (JAGS). "I saw people who never thought about activism pick up a sign and enjoy it."

"The [protest] was my first foray into activism," mentioned local transgender Mysty Joseph of Jacksonville. When asked her opinion on this type of action, Ms. Joseph replied it "was constructive, and would not hesitate to be involved in the future."

"Peaceful demonstration can be an effective tool, but should be a last resort, applied when communication has failed; as in the Winn-Dixie case."

Another first-time protester who drove down from Iowa City, Iowa was outraged; declaring Winn-Dixie's acts as 'Orwellian'. "The parallel between the book '1984' and [the Oiler case] is not a big leap," said NTAC member, Sandra Stevens. In an interview with National Public Radio reporters at the protest site, Stevens, who drove 1,300 miles for the protest, said "if this is not challenged now, the corporations will stop at nothing to control the very lives of the people who work for them."

Participation in this year's action was double the previous year's number. Many attribute this to the recent death of last year's local organizer, Terriane Summers. The transgender activist, who lived merely a mile from the Winn-Dixie national headquarters, was murdered December 12, 2001. The as-yet-unsolved killing galvanized the Jacksonville community.

"Many members of the community participated to honor Terriane," Ms. Wilson continued, "and now that they have arrived, I think many members are here to stay."

NTAC's Vice Chair, Vanessa Edwards Foster, traveled from Houston for both Summers' memorial service and for the Winn-Dixie campaign. She remembered her slain friend as "an activist's activist," and a protegee with an indomitable spirit. "Terriane was the backbone of last year's protest; drawing a large contingent of participants from JASMYN (the Jacksonville Area Sexual Minority Youth Network)." JASMYN again sent a large number to participate in this year's action.

"The firing of Peter Oiler sent a message to the transgender community," added Ms. Foster, also Media Director for the national transgender civil rights organization. "Our increased participation this year is our clear response to that message: We're not going away."

The sidewalk protest "served to raise awareness about what it is to live a transgendered life; and that the type of corporate discrimination deployed by Winn-Dixie should stop," said President of Jacksonville's ACLU, Ken Hurley. Attending the protest with three others from the local ACLU, Hurley added that the suit seeks to "correct the injustice done to Mr. Oiler, and to establish case law that should help eliminate this type of sexual discrimination in the workplace."

One protester who stopped to pick up lunch at a fast food franchise a block away from Winn-Dixie recounted a telling slice of public opinion in Jacksonville. Melissa White of suburban Atlanta described how "women standing in line began talking of how awful it was what Winn-Dixie did to that man that crossdressed."

## PFLAG PUTS THE T IN GLBT

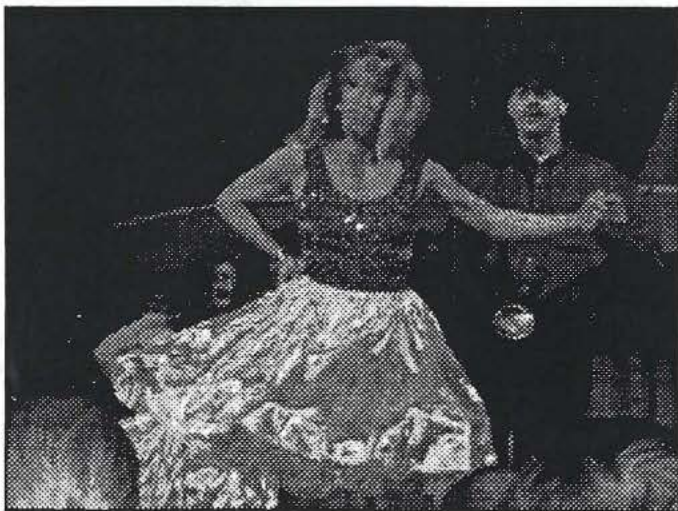

In 1972, a young gay man was beaten during a gay rights protest in New York while police stood by and did not interfere. Following this act of violence, a mother, Jeanne Manfred, stood up and protested what had been done to her son. She later marched with him in New York's Pride Parade. Cheered by gay and lesbian youth in the crowd, she realized that one of the saddest parts of being 'queer' was not having the support of family members and friends. Soon thereafter, a local organization, Parents and Friends of Gays, was born. About 20 people attended the first formal meeting in a local church.

Today, the organization called Parents, Family and Friends of Lesbians and Gays, has over 80,000 members with close to 500 affiliate groups in the United States. PFLAG is not an organization of gay people, although some are members. Rather, it is an organization whose mission is to promote the health and well-being not only of those who are labeled 'queer' but, also, of their families and friends.

Courtney Sharp is a transsexual. She is also an engineer who was terminated by her employer following her refusal to resign due to her transition. As a result, she became a transgender activist. She has worked to promote understanding of transgender people and issues in New Orleans and the Gulf Region. She has gained national attention in such causes as seeking redress for the firing of a Winn-Dixie employee for crossdressing on his own time.

What do Courtney Sharp, transgendered activist, and PFLAG have in common? Ms. Sharp was appointed to the national board of directors of PFLAG in October 2001 following years of work in advocating the inclusion of transgendered people under the PFLAG umbrella. She is the first transgendered person to serve on this national body, although there are many others who serve in local and regional positions. Another member of the national board, Mary Boenke, is the mother of a transsexual. Ms. Boenke was also instrumental in raising the awareness of PFLAG to the need to provide transgendered people and their families and friends the same measure of support as for the gay community. Mary is Chairman of PFLAG's Transgender Network.

Although PFLAG has not continued to add words to its name or letters to the acronym, its mission has been expanded in recent years to include parents, families and friends of lesbian, gay, bisexual, and transgendered persons. PFLAG outreach and education efforts are inclusive and explain that the transgender experience exposes people to the same issues, concerns, risks, and dangers as those to which members of the gay community are exposed.

Courtney Sharp has suffered losses from being true to her own identity. She lost her job and much of her family when she began her transition to female. Many, if not most, transsexuals suffer similar losses when they choose between continuing to live a lie and becoming who they really are. Other members of the transgender community, such as the more prevalent crossdressers, also face discrimination and disgrace should their secret be revealed. Outside of the military and certain youth and religious organizations, the gay community has begun to overcome such discrimination, but on the individual level all need the support and understanding of family and friends.

Some members of the sometimes-fractious transgender community feel that the gay/lesbian/bisexual communities do not take transgender issues to heart, that certain organizations are willing to sacrifice the transgendered in order to further their own agendas. Not so with PFLAG. Although not all of the letters are spelled out in the name, PFLAG is truly an organization working to support the entire GLBT community. The PFLAG vision makes this clear:

We, the parents, families and friends of lesbian, gay, bisexual and transgendered persons, celebrate diversity and envision a society that embraces everyone, including those of diverse sexual orientations and gender identities. Only with respect, dignity and equality for all will we reach our full potential as human beings, individually and collectively.

Courtney Sharp's experience as a member, secretary, vice-chairman, and chairman of the New Orleans Mayor's Advisory Committee on Gay, Lesbian, Bisexual & Transgender Issues will be valuable to PFLAG at the national level, as will her continuing experience as a member of the her local PFLAG chapter and the Gulf Gender Alliance and board member of the Louisiana Lesbian & Gay Political Action Caucus.

Courtney considers that there is much work yet to be done within PFLAG. "The transgender work is not separate from the other work PFLAG is doing," she says. "Providing resources and support to chapters is important. Ensuring that the needs of gender-variant and transgender students are addressed in the Safe Schools Programs is extremely important. Outreach into diverse communities, and providing support for GLBT families in these communities is important. Reaching out to Communities of Faith is important."

As this energetic leader and activist works to build understanding within the greater GLBT community, she looks forward to a time when, "no gay and lesbian political organization will misuse its power to oppress any other minority under the guise that its actions are somehow unobjectionable or justified. When they fall into this trap, they too impose their own moral code upon others. If we only allow others to live their lives in ways which all others find unobjectionable, there would be no such thing as liberty, much less justice, for all."

PFLAG has not fallen into that trap and is to be congratulated for its efforts to make the world a better place for all who do not meet the expectations of narrow minded elements of our society.

## WINN-DIXIE: CROSS-DRESSING GOT MAN FIRED

NEW ORLEANS — Southern grocery giant Winn-Dixie has conceded that its sole reason for firing an employee of two decades was that off-duty he sometimes cross-dressed as a woman.

The American Civil Liberties Union asked a federal judge Wednesday for ruling without a trial in its sex discrimination lawsuit against the company.

"We don't need a trial, because there's no disagreement over what happened. The only disagreement is whether it's legal to fire someone for this," said Ken Choe, the ACLU Lesbian & Gay Rights staff attorney handling the case.

Peter Oiler was fired on Jan. 5, 2000, after his supervisors and company executives learned that he occasionally cross-dresses as a woman away from work.

Oiler and his wife, Shirley, who will celebrate their 25th wedding anniversary on Feb. 4, lost their health insurance and nearly lost their home.

In October 2000, the ACLU filed a federal lawsuit on Oiler's behalf, claiming that Winn-Dixie engaged in sex stereotyping in violation of state and federal laws that bar sex discrimination.

Choe said that over the last few months the ACLU has deposed the men who fired Oiler and has determined that there is no dispute that would require a trial. "They are very clear that he wasn't fired for job performance — in fact he received numerous raises and promotions," Choe said.

Wednesday's "Motion for Summary Judgment" cites Winn-Dixie Louisiana President Michael Istre's sworn deposition saying that he made the decision to fire Oiler and that the sole reason was that Oiler didn't conform to the company's stereotyped notions of how a man should look, dress and act.

In a deposition, taken Dec. 11, Istre said: "I was concerned about my business and what kind of impact and effect that this — this type of behavior would have on my business and my customer base that if my customers saw him — and that's pretty much it. Why? The reason why was because of my business, what kind of effect it would have on my customer base."

The ACLU cited a sworn deposition from Oiler's supervisor, Gregory Miles, who said Oiler was fired because members of the public who saw Oiler cross-dressed away from work would somehow "put two and two together" and associate him with Winn-Dixie. This, he speculated, could cause people to think Winn-Dixie approved of Oiler's personal life and might lead people to buy groceries elsewhere.

Winn-Dixie will have until Feb. 22 to reply to today's motion. A hearing is set for April 10 in U.S. District Court for the Eastern District of Louisiana.

When an older gentleman became curious about their conversation, Ms. White added that "the first women started explaining the case to the older man, and others who began listening in offered their opinions," all shocked and dismayed at Winn-Dixie's behavior.

It appears public opinion may be aligning behind the Oilers' case. "They recognize that a corporation that would limit an employee's freedom to express his identity also [would] not respect the other basic rights," said Courtney Sharp, a transgender activist who traveled to the protest from New Orleans.

A member of NTAC, Ms. Sharp is the impetus behind the Winn-Dixie campaign as well as one of the creators of the ShameOnWinnDixie website. Recently, attorneys for Winn-Dixie sent a letter demanding the web site be shut down. "The attempts to shut down the web site," Sharp continued, "were indications of a systemic erosion of personal freedoms within Winn-Dixie."

Although the Oilers suffered a tough period immediately following the firing, Peter Oiler has since secured new employment with a more desirable company. Oiler has no intentions of returning to Winn-Dixie regardless of the outcome of the case.

ACLU's Ken Hurley summed it up thusly: "Civil Rights emanate from civil wrongs. Winn-Dixie is wrong."

## "No Promo Homo" Bill DEFEATED IN ASSEMBLY

Good news! The Assembly Education Committee has just defeated AB 1326 the bill which would "prohibit the promotion of homosexuality in public schools."

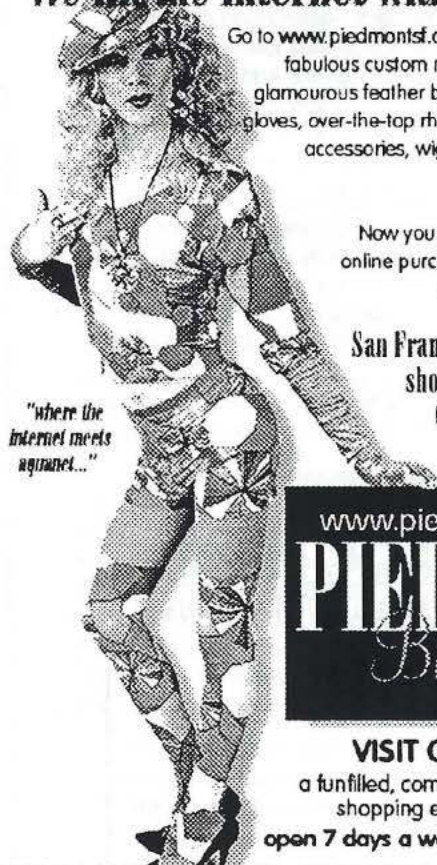
